

**NEWPORT CITY COUNCIL
(RINGLAND CIRCLE, NEWPORT)**

**(TEMPORARY PROHIBITION OF TRAFFIC)
ORDER 2019**

NOTICE is hereby given that Newport City Council in exercise of its powers under the Road Traffic Regulation Act 1984 (as amended) intends not less than 7 days from the date of this notice to make an order the effect of which will be to prohibit any vehicle from proceeding along Ringland Circle - from its junction with Aberthaw Road to 87 Ringland Circle. The alternative route will be signed via Aberthaw Road and Ringwood Avenue. The reason for making the order is to enable carriageway reconstruction to take place. The proposed order will be operative from 25 April 2019 and will continue in force for a period not exceeding 18 months or until the works which it is proposed to carry out have been completed, whichever is the earlier. It is anticipated that the works will be completed in 1 week. Pedestrian access will be available at all times. Emergency vehicle access will not be available for the duration of these works.

HYSBYSIR drwy hyn bod Cyngor Dinas Casnewydd wrth ymarfer ei bwerau dan y Ddeddf Rheoleiddio Traffig Ffyrdd 1984 (fel y'i diwygiwyd), yn bwriadu gwneud gorchymyn mewn ddim llai na 7 diwrnod o ddyddiad yr hysbysiad hwn, a fydd â'r effaith o wahardd cerbydau rhag mynd ar hyd Ringland Circle - o'i chyffordd gyda Aberthaw road i 87 Ringland Circle.
